#### ORDER:

During the Budget Speech for the year 2013-14, the Hon'ble Minister for Finance has made the following announcement:-

**“During 2013-2014, 425.92km of roads will be improved in 281 Town Panchayats at a cost of Rs.103 crores with NABARD assistance.”**

2. Pursuant to the above, the Director of Town Panchayats has sent the proposal for the works of improvement of roads, construction of bridges, Storm water drains and Slaughter houses at a cost of Rs.180.90 crore under NABARD RIDF- XIX for the year 2013-14.

3. In the 59<sup>th</sup> High Power Committee meeting for the NABARD Schemes held on 25.02.2013, it was decided to allocate a sum of Rs.150.00 crore for improvement of roads, Bridges, Drainage, Modern Slaughter Houses, etc., in Town Panchayats.

4. Based on the above decision, the Director of Town Panchayats has sent the revised proposal for Rs.103.00 crore towards the improvement of 332 roads to a length of 425.92 km in 281 Town Panchayats under NABARD RIDF XIX for the year 2013-14 and also sent the sectorwise details in this regard and requested the Government to accord Administrative Sanction for the above works.

5. The Government after careful consideration, accord Administrative Sanction for improvement of 332 roads to a length of 425.92 Km in 281 Town Panchayats at a cost of Rs.103.00 crore (Rupees One hundred and three crore only) as detailed in the annexure to this order under NABARD loan assistance RIDF XIX for the year 2013-2014.
