ORDER:

The Tamil Nadu Institute of Urban Studies, Coimbatore
now badly in need of proper accommodation. **Sanction is**
therefore accorded for the construction of the adminis-
trative block of the Tamil Nadu Institute of Urban Studies,
Coimbatore at an estimated cost of Rs.10.50 lakhs (Rupees
ten lakhs and fifty thousand only in the land placed at
its disposal by the Corporation of Coimbatore.

2. The cost of constructing the administrative block
shall be met from the funds of the Tamil Nadu Institute of
Urban Studies, Coimbatore and from the special contribution
amounting to Rs.4.65 lakhs (Rupees four lakhs and sixty
five thousand only) to be paid to it by the Municipal Councils
and Township Committees and the Corporations of Madras,
Madurai and Coimbatore for this purpose, with reference
to the direction in para 3 below.

3. As the Tamil Nadu Institute of Urban Studies,
Coimbatore functions for the benefit of all Municipal
Councils, Township committees and Corporations, the
Government hereby direct them to pay a special contribution
to the Tamil Nadu Institute of Urban Studies, Coimbatore
during 1983-84 at the rate of annual contribution ordered in
the G.O. first read above towards the cost of construction
of the administrative block of the Institute, in addition
to their usual annual contribution.

4. The Government direct that the work of constructing the administrative block of the Tamil Nadu Institute of Urban Studies, Coimbatore be entrusted for execution to Public Works Department as a deposit work.

5. The Chief Engineer, Public Works Department (Building) is requested to commence the work early and complete the construction expeditiously to avoid escalation in the cost of work.
