APPENDIX

NOTIFICATION

Under sub-section (2) of section 8 of the Tamil Nadu Public Health Act, 1939 (Tamil Nadu Act III of 1939), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Municipal Public Health Service Regulations, 1970.

AMENDMENTS

In the said Regulations, in regulation 6, in the tabular column,-

(1) under Class II, in column (2), against the entry "Categories 1 and 2" in Column (1), for Clause (a) the following clause shall be substituted, namely:-

"(a) Must have worked as Sanitary Inspector.";

(2) under Class IV, in column (2), against the entry "Category 1" in Column (1), in clause (a), for the expression "Must possess a Sanitary Inspector's Certificate", the following expression shall be substituted, namely:-

"Must possess a degree in B.Sc., (Chemistry) with a Sanitary Inspector's Certificate."
