ORDER:

In Government Order read above, Government have accorded Administrative Sanction for a sum of Rs.7.00 crore and also accorded financial sanction for the year 2012-13, for a sum of Rs.3.50crore to the Director of Town Panchayats as first instalment for construction of office buildings for 15 Town Panchayats and office of the Assistant Director of Town Panchayats, Tirunelveli Zone. The balance amount of Rs.3.50 crore will be released in 2013-14 based on the progress of the works.

2. In the letters second read above, the Director of Town Panchayats has furnished the Utilization Certificate for the amount of Rs.3.50 crore released for the Construction of Office Buildings in 15 Town Panchayats & Assistant Director of Town Panchayats office in Tirunelveli Zone during 2012-13 and requested the Government to release the balance amount of Rs.3.50 crore for the year 2013-14 so as to complete the works.

3. The Government after careful consideration of the proposal of the Director of Town Panchayats and sanction the balance amount of sum of Rs. 3,50,00,000/- (Rupees three crore and fifty lakhs only) to the Director of Town Panchayats for the construction of office buildings for 15 Town Panchayats and office of the Assistant Director of Town Panchayats in Tirunelveli Zone for the year 2013-14.

4. The amount sanctioned in para 3 above shall be debited to the following head of account:-
