**NOTIFICATION**

In exercise of the powers conferred by section 347 of the Chennai City Municipal Corporation Act, 1919 (Tamil Nadu Act IV of 1919), section 303 of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920), section 431 of the Madurai City Municipal Corporation Act, 1971 (Tamil Nadu Act 15 of 1971), section 430 of the Coimbatore City Municipal Corporation Act, 1981 (Tamil Nadu Act 25 of 1981), read with section 8 of the Tiruchirappalli City Municipal Corporation Act, 1994 (Tamil Nadu Act 27 of 1994), section 8 of the Tirunelveli City Municipal Corporation Act, 1994 (Tamil Nadu Act 28 of 1994) and section 8 of the Salem City Municipal Corporation Act, 1994 (Tamil Nadu Act 29 of 1994), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Municipalities Television Cables Installation Regulation Rules, 2000:-

2. The amendment hereby made shall come into force with effect on and from the **1<sup>st</sup> April 2014**.

**AMENDMENT**

In the said Rules, in rule 4, for sub-rule (1), the following sub-rule shall be substituted, namely:-

“(1) The annual rent to be collected by the Municipal Corporations, Municipalities and Town Panchayats for using the street light poles and for erecting additional poles by the applicants for the installation of television cables shall be as specified in the Table below:-

**THE TABLE**

<b>Sl.No. (1)</b>	<b>Local area (2)</b>	<b>Annual Rent (3)</b>
1)	Chennai City Municipal Corporation	Rs.32,450/- (Rupees Thirty two thousand four hundred and fifty per annum per kilometre)
2)	All City Municipal Corporations other than Chennai City Municipal Corporation	Rs.21,749/- (Rupees Twenty one thousand seven hundred and forty nine per annum per kilometre)
3)	Municipalities	Rs.18,987/- (Rupees Eighteen thousand nine hundred and eighty seven per annum per kilometre)
4)	Town Panchayats	Rs.6,050/- (Rupees Six thousand and Fifty per annum per kilometre)

Provided that the annual rent shall be subject to an automatic increase of ten percent per annum of the rent prescribed above.
