#### **ORDER:**

In the Government Order first read above, the Government have accorded administrative sanction for the implementation of Kreditanstalt fur Wiederaufbau (KfW) assisted Sustainable Municipal Infrastructure Financing in Tamil Nadu (SMIF-TN) Program. The total outlay of the project is Euro 77 million consisting of Euro 65 million development loan for refinancing of sub-projects, Euro 10 million (equivalent to about Rs.65 crores) standard loan for Master Financing Indenture (MFI), and Euro 2 million (equivalent to about Rs.13 crores) complementary measures (grant) towards Technical Assistance for capacity building and project advisory assistance.

2. The Principal Secretary/Chairperson and Managing Director, Tamil Nadu Urban Infrastructure Financial Services Limited, in the letter third read above, has stated that the allotted amount of Rs.13 crore under the complementary measures, a sum of Rs.9 crore has been drawn as grant under Sustainable Municipal Infrastructure Financing in Tamil Nadu Program from Government of Tamil Nadu as detailed below:-

3. The Principal Secretary/Chairperson and Managing Director, Tamil Nadu Urban Infrastructure Financial Services Limited, has further stated that the amount of Rs.9 crore withdrawn from Government, a sum of Rs.6.72 crore has been disbursed for the various consultancy studies under Sustainable Municipal Infrastructure Financing in Tamil Nadu Program up to 31.01.2014 as detailed below :-

The Principal Secretary/Chairperson and Managing Director, Tamil Nadu Urban Infrastructure Financial Services Limited has requested the Government to issue orders for release of an amount of Rs.2 crore to Kreditanstalt fur Wiederaufbau (KfW) Grant Fund-II, as the funds are required to meet the expenditure towards various consultancy projects.

The Government after careful examination accept the proposal of the Principal Secretary/Chairperson and Managing Director, Tamil Nadu Urban Infrastructure Financial Services Limited at para 4 above and accord sanction for release of Rs.2 crore (Rupees two crore) as grant to Kreditanstalt fur Wiederaufbau (KfW) Grant Fund-II, so as to meet the expenditure towards various consultancy projects.

6. The amount sanctioned in para 5 above shall be debited to the following head of account:-
