### **ORDER:**

In the letter read above, the Commissioner of Town and Country Planning has stated that a proposal seeking fund of Rs.15 crore for 8 projects under Infrastructure and Amenities Fund has been received from the Municipal Commissioner, Thanjavur Municipality through the District Collector, Thanjavur. The District Collector, Thanjavur has recommended for the following projects along with estimate under Infrastructure and Amenities Fund:-

2) Further, the District Collector, Thanjavur, has informed that all the above proposals are found important to the Thanjavur town and for improvement of traffic and has hence, recommended for administrative sanction and to provide full grant, works out to Rs.1370.00 lakhs from Infrastructure and Amenities Fund.

3) Based on the above, the Commissioner of Town and Country Planning has stated that the above subject was placed before the Infrastructure and Amenities Promotion Committee meeting held on 17.05.2013, as Agenda No. 8 and the Committee has decided as follows:-

“The Committee recommended for sanction of fund to a tune of Rs. 4.11 crore to Thanjavur Municipality for the following projects:-

- (1) Construction of centre median drain, lighting arrangements and BT surface at old railway link road (North side of New Bus Stand).
- (2) Formation of B.T. surface as medical college road E1E1 road.
- (3) Construction of Road Bridge across GA canal at Sivaji Nagar and Sevappanyakanwari area.
- (4) The project viz., providing multi level two wheeler parking at Thanjavur new bus stand may be financed from financial institution as it is commercial project and the financial viability gap alone be funded from Infrastructure and Amenities Fund.”

4) In this connection, the Municipal Commissioner, Thanjavur Municipality has stated that for providing multi level two wheeler parking at Thanjavur New Bus Stand, action will be initiated by availing fund from financial institution sponsored by the Municipality and requested sanction for other 3 projects.

5) The Government, after careful examination of the proposal of the Commissioner of Town and Country Planning, accord sanction of fund to the tune of Rs. 4.11 crore (Rupees four crore and eleven lakh only) to Thanjavur Municipality for the following 3 (three) projects:-

- (1) Construction of centre median drain, lighting arrangements and BT surface at old railway link road (North side of New Bus Stand).
- (2) Formation of B.T. surface as medical college road E1E1 road.
- (3) Construction of Road Bridge across GA canal at Sivaji Nagar and Sevappanyakanwari area.

6) The amount sanctioned in para 5 above shall be debited to the following new head of account:- under Demand 34 -02:-

“2217.Urban Development – 05. Other Urban Development Schemes – 800. Other expenditure – Schemes in Twelfth Five year plan – II State Plan – KA. Schemes implemented in Urban Local Bodies under Infrastructure and Amenities Fund – 09. Grants in Aid – 02. Grants for creation of Capital Assets”.

(DPC 2217 – 05 – 800 – KA – 09 24)

7) The expenditure sanctioned in para 5 above shall be adjusted by deducting under following head of account:-

“2217 – Urban Development – 05 – Other Urban Development Schemes – 902 – Deduct – Amount met from Infrastructure Development Fund – JC. Amount met from State Infrastructure and Amenities Fund – 30. Inter Account Transfers.

(DPC – 2217 – 05 – 902 – JC – 3002)

by contra debiting “ J. Reserve funds (b) Reserve Funds not bearing interest – 82229-00. Development and Welfare Funds – 200. Other Development and Welfare Funds – AZ – State Infrastructure and Amenities Fund.

8) The Commissioner of Municipal Administration is the Estimating, Reconciling and Controlling authority of the New Head of Account mentioned in para 6 above.

9) The concerned Pay & Accounts Officer/Treasury Officers are requested to open new head of account in their books and to make necessary adjustments at the end of the financial year 2013-2014.

10) The item of expenditure is treated as “**New Service**”. The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by sanction of an advance from the Contingency Fund, orders regarding which the Government in Finance (BG-I) Department will issue separately. The Commissioner of Municipal Administration is directed to send necessary proposals to Government in Finance (BG-I) Department, in the prescribed format along with a copy of this order for sanction of advance from Contingency Fund acquired immediately for the correct financial year.

11) This order issues with the concurrence of the Finance Department vide it's U.O.No.376/Finance (MAWS)/2013, dated :31.01.2014 and ASL No. 2775 (Two thousand seven hundred and seventy five ).
