ORDER:

The Commissioner of Municipal Administration in his letter second read above has informed that, based on the findings of a study, under Litter Free Project in Tambaram Municipality 157 locations were identified in 10 pilot wards with public consultation through focused group discussion. The project envisages introduction of deep collection bins (underground/ semi underground/ above the ground) based on the waste generated by the households in the bin locations in 10 wards on pilot basis.

2. The Commissioner of Municipal Administration has also informed that the Project Sanctioning Committee constituted in the Government Order first read above under the Solid Waste Management Fund, in its second meeting held on 4.02.2014 had approved the Litter Free project in Tambaram Municipality in 10 wards (Ward No. 1, 28, 29, 30, 31, 33, 34, 37, 38 & 39) on pilot basis, at a cost of Rs.876.68 lakhs with the following funding pattern:-

Capital Grant from SWM Fund (90%)	Rs.789.01 lakh
ULB Contribution (10%)	Rs.87.67 lakh
Total	Rs. 876.68 lakh

3. The Tambaram Municipal Council in its resolution No.1696, dated 27.6.2014 has accepted the above project and permitted to contribute Rs.87.67 lakh to the above project from the General funds of the Municipality.

4. The Commissioner of Municipal Administration has requested the Government to accord Administrative Sanction for the litter free project in Tambaram Municipality at a cost of Rs.876.68 lakh and release an amount of Rs.789.01 lakh as 90% grant to the Tambaram Municipality for the above said project under the Solid Waste Management Fund for the year 2013-2014.

5. The Government after careful examination, accepts the proposal of Commissioner of Municipal Administration and accords sanction for the litter free project in Tambaram Municipality, at a cost of Rs.876.68 lakh (Rupees Eight crore seventy six lakh sixty eight thousand only) and to release a sum of Rs.789.01 lakh (Rupees Seven crore eighty nine lakh one thousand only) as 90% grant to the Tambaram Municipality under the Solid Waste Management Fund for the year 2013-2014.

6. The amount sanctioned in para 5 above shall be debited to the following head of account:-

2217. Urban Development – 80. General – 800. Other Expenditure –I. Non Plan – AH. Grants for Clean Village Campaign Scheme -09. Grants-in-aid-03. Grants for Specific Schemes. (DPC : 2217-80-800-AH-0938)

7. The Director of Municipal Administration is authorized to draw the amount sanctioned in para 5 above from the Pay and Accounts Officer (East), Chennai-8 and disburse the same to the Municipal Commissioner, Tambaram Municipality.
