### **ORDER:-**

The Director of Town Panchayats in his letter read above has furnished the objectives of the Study on impact of application of human waste (Urine & Faecal Compost) on soil health and ground water quality & promotion of ECOSAN UDDT which are as detailed below:

- i. Characterisation of Faecal compost and urine for nutritive, ameliorative and pollution potential and suitability of soil application.
- ii. Evaluating the use of faecal compost and urine for the crop growth, yield and quality parameters.
- iii. Assesing the impact of faecal compost and urine application on ground water eco-system.
- iv. Promotion of alternative toilet technology.

2. The Director of Town Panchayats has therefore requested the Government to provide an amount of Rs.3.97 lakhs to Musiri Town Panchayat to Study on impact of application of human waste on soil health and ground water quality for promotion of ECOSAN UDDT, under Part-II Scheme for 2014-15.

3. The Government, after careful examination, accept the proposal of Director of Town Panchayats and sanction a sum of Rs.3.97 lakhs (Rupees Three

Lakhs and Ninety Seven Thousands only) for the Study on impact of application of human waste on soil health and ground water quality for promotion of ECOSAN UDDT in Musiri Town Panchayat, Trichy District, under Part-II Scheme for 2014-15.

4. The amount sanctioned in para 3 above shall be debited to the following head of account under Demand No. 34.02:-
