Collector's Conference 2013 - Announcement made by the Hon'ble Chief Minister - Establishment of "Amma Unavagam" in Government Rajaji Hospital, Madurai - Orders - Issued.

ORDER:

In the reference first read above, the Government issued orders for opening of 90 Amma Unavagams in each 10 of the nine Corporations viz. Madurai, Coimbatore, Tiruchirappalli, Salem, Tirunelveli, Tiruppur, Erode, Vellore and Thoothukudi in the State. All the above Amma Unavagams have been inaugurated by the Hon'ble Chief Minister on 02.06.2013 to eradicate the starvation and to provide hygienic food at affordable prices to the poor and vulnerable sections of urban population.

2. During the Collector's Conference, 2013 the Hon'ble Chief Minister has announced that "Amma Unavagam" will be opened in Government Rajaji Hospital, Madurai for the benefit of poor people who are daily visiting the Government Hospitals for treatment in addition to the inpatients.

3. In the letter second read above, the Commissioner of Municipal Administration has furnished the following details for the establishment of Amma Unavagam in Government Rajaji Hospital, Madurai:

- A sum of Rs.25 lakhs is estimated for the establishment of the center, purchase of kitchen utensils and creation of other infrastructures facilities.

- Details of quantity of food items to be prepared and served per day, the actual selling cost and deficit taking into account of 300 plates(4 each) of Idlies with Sambar, 300 Sambar Rice and 300 Curd Rice are as follows:-
 - Total estimated cost for the preparation of 1200 Idlies with Sambar is Rs.4,368/- and the cost of preparation of 1 Idly with Sambar is Rs 3.64. If the proposed selling cost of Rs.1/- for one Idly with Sambar is taking into account, the deficit amount will be Rs.2.64.
 - Total estimated cost for the preparation of 300 Sambar Rice is Rs.4,419/- and the actual cost of preparation of one Sambar Rice is Rs.14.73. If the proposed selling cost of Rs.5/- per Sambar Rice is taking into account, the deficit amount will be Rs.9.73.
 - Total estimated cost for the preparation of 300 Curd Rice is Rs.2,232/- and the actual cost of preparation of one Curd Rice is Rs.7.44. If the proposed selling cost of Rs.3/-per Curd Rice is taking into account, the deficit amount will be Rs.4.44.
 - If 300 plates of Idly with Sambar, 300 plates of Sambar Rice and 300 plates of Curd Rice are proposed to sell in each of the two centers at a cost of Re.1/-, Rs.5/-, and Rs.3/- respectively, the deficit amount per day worked out will be Rs.7419/- and per year will be Rs.27,07,935/-
- For the preparation of Idlies, Sambar Rice and Curd Rice and serving etc., the services of the 12 self help group members will be utilized. They will be paid a salary of Rs.250/- per day.
- The activities such as establishment of the centre, creation of infrastructure facilities and purchase of Kitchen utensils etc. are carried out by the Madurai Corporation and the activities such as running of the Amma Unavagam including purchase of Vegetables, groceries etc., day-to-day administration of the centre, cleaning and up keeping of the center etc., will be done by the Hospital Authorities for opening of "Amma Unavagam" in Government Rajaji Hospital, Madurai.
- Madurai city Municipal Corporation Council in its resolution No.540 dated 21.11.2013 has resolved to establish Amma Unavagam in Government Rajaji Hospital, Madurai.

4. The Commissioner of Municipal Administration has requested the orders of Government for the establishment of "Amma Unavagam" in Government Rajaji Hospital, Madurai.

5. The Government after careful examination accepts the above proposal of the Commissioner of Municipal Administration and accord permission to the Commissioner of Municipal Administration for the following:

- To grant necessary permission for opening of "Amma Unavagam" in Government Rajaji Hospital, Madurai
- To accord Administrative sanction to entrust the activities such as establishment of the centre, renovation for the existing Buildings, day-to-day administration of the centre, Cleaning and up-keeping of the centre, creation of infrastructure facilities and purchase of Kitchen utensils etc., are carried out by the Madurai Municipal Corporation General Fund.
- To permit the Madurai Municipal Corporation to purchase rice from the Tamil Nadu Civil Supplies Corporation Limited in subsidized rate, if bulk allotment is made by Government of India otherwise to purchase the rice from the open market from their General Fund.
- To purchase Urad Dhal, Toor Dhal, Chilly, Tamarind, Turmeric powder, mustard, fenugreek and Cooking Oil from the Amudham / Tamil Nadu Civil Supplies Corporation Limited.
- To purchase vegetables through open market on the prevailing rates.
- To purchase the required curd on wholesale rate basis through Aavin.
- The deficit amount for implementing the above scheme will be met-out from the Madurai Municipal Corporation General Fund.

6. The Government also directs the hospital authorities of the Government Rajaji Hospital, Madurai, to provide space as per the requirement as done in General Hospital in Chennai and also to replicate the arrangement made in Chennai.
