### **ORDER:-**

In the letters read above, the Commissioner of Municipal Administration has stated that the Sivagangai Municipality was constituted as Third Grade Municipality from Town Panchayat on 01.04.1965 and upgraded as First Grade Municipality on 22.05.1998. This is a district head quarter town, connected by both road and rail. The extent of the town is 6.97 sq.km and the population is 42,053 as per 2011 census. The Municipality is maintaining road length of 46.02 kms, 2,609 No. of street lights, 7 parks, 1 bus stand, 1 daily market, 1 weekly shandi and 3 Municipal Schools. A total quantity of 3.80 MLD of water is supplied by the ULB through its 83 km of water pipeline. The Municipality is due to celebrate its Golden Jubilee during the year 2015 (01.04.2015).

2. During the Assembly Session, while replying to His Excellency the Governor's Address, the Hon'ble Chief Minister has made an announcement on 03.02.2014, that an amount of Rs.25.00 crore will be sanctioned for taking up new works on the occasion of Golden Jubilee Celebration in Sivagangai Municipality.

3. Based on the Announcement made by the Hon'ble Chief Minister, the Commissioner of Municipal Administration has sent the proposal on 05.02.2014, received from the Municipal Commissioner, Sivagangai Municipality seeking financial assistance to accord administrative sanction for the sum of

Rs.25.00 crore to take up new works on the occasion of Golden Jubilee Celebration in Sivagangai Municipality as detailed below:-
