

ABSTRACT

WATER SUPPLY – Combined Water Supply Scheme to 146 Rural habitations in Manikandam Union of Trichy District and 5 habitations in Viralimali Union of Pudukottai District with bulk provision to 22 habitations in Anthanallur Union, Power grid corporation of India and TNEB Quarters at Anthanallur in Trichy District at a cost of Rs.1634.53 lakh – Revised Administrative Sanction - Orders issued.

ORDER:

In G.O.Ms.No.134, Municipal Administration and Water Supply (WS3) Department, dated 8.9.2005, administrative sanction was accorded for Rs.1312.00 Lakhs for installation under Minimum Needs Programme and Rs.30.00 lakhs for annual maintenance for the Combined Water Supply Scheme to 146 rural habitations in Manikandam Union, 5 enroute habitations in Viralimalai Union with bulk provision to 22 habitations in Andanallur Union and Power Grid Corporation of India Ltd and TNEB quarters at Alundur in Trichy district.

2. The Managing Director, Tamil Nadu Water Supply and Drainage Board in his letter read above, has submitted a proposal to accord Revised Administrative Sanction for providing CWSS to 146 rural habitations in Manikandam Union and 5 enroute habitations in Viralimalai union of Pudukkottai district with bulk provision to 22 habitations in Andanallur union

and power Grid of Pudukkottai district with bulk provision to 22 habitations in Andanallur union and Power Grid Corporation of India limited and TNEB quarters at Alundur in Trichy district for Rs.1634.53 Lakhs with an excess of Rs.322.53 Lakhs, (24.58% excess) under MNP fund.

- 3. The Managing Director, Tamil Nadu Water Supply and Drainage Board has stated that Technical Sanction was accorded for the above scheme for Rs.1291.00 lakh and revised Technical Sanction was accorded for the above scheme for Rs.1256.00 lakh and the actual expenditure incurred for the completion of the above CWSS is Rs.1634.53/- lakh. Original administrative sanction is Rs.1312.00 lakh (24.58% excess over the administrative sanction). Hence, he has sent the revised estimate to Government for approval.
- 4. The Managing Director, Tamil Nadu Water Supply and Drainage Board has furnished the following reasons for Revised Estimate:
 - 1. The work was awarded to various Contractors /Firms vide Head works and Packages I to XI for a total value of Rs.11,78,99,448/-against the Department Value of Rs.10,15,96,847/- at the Tender excess premium ranging from 4.95% to 37%. Hence, the total excess value for the actual work done works out to Rs.126,30,628/- i.e (+) 12.43% excess over the Department value.
 - 2. For the finalization of works with the Contractors/Firms, tenders were called for 5 times. As such paper advertisement charges as per Government/Board norms were paid. Hence Expenditure has increased.
 - 3. For laying of pumping main/Branch mains in NH67, NH 45 B and crossing of Railway lines of Trichy- Karur and Trichy- Dindigul the road restoration charges were paid as per the demand raised by the above Departments which is excess over the provisions made in the original estimate. The excess amount is Rs.1,44,39,154/-.
 - 4. Power consumption paid to TNEB during the maintenance period has increased. The excess amount is Rs.19,94,042/-.
- 5. The Board in its resolution No.2.2, dated:6.12.2013 has resolved to recommend the proposal to Empowered committee for according Revised Administrative approval. Based on the recommendation of the Board, the

Empowered committee has resolved to accord Revised Administrative Approval for the above proposal.

- 6. The Government after careful consideration accord Administrative sanction for providing Combined Water Supply Scheme to 146 rural habitations in Manikandam Union and 5 enroute Habitations in Viralimalai union of Pudukkottai district with bulk provision to 22 habitations in Andanallur union and power Grid of Pudukkottai district with bulk provision to 22 habitations in Andanallur union and Power Grid Corporation of India limited and TNEB quarters at Alundur in Trichy district for Rs.1634.53 Lakhs with an excess of Rs.322.53 Lakhs, (24.58% excess) under MNP fund.
