#### **ORDER:**

In the letter fourth read above, the Commissioner of Municipal Administration has stated that the Common Committee for Infrastructure and Operation and Maintenance Gap Filling Fund, in its meeting dated 20.05.2013 had approved, among others, the following Water Supply Improvement works to the Madurai Municipal Corporation under the Infrastructure Gap Filling Fund:

2. In this connection, the Commissioner, Madurai Municipal Corporation in his letter second read above has stated that the Madurai Municipal Corporation has prepared Detailed Project Report as follows:
