Tamil Nadu Water Supply and Drainage Board – Constitution of High Level Committee for getting clearance from Line Departments to implement Combined Water Supply Schemes and Under Ground Sewerage Schemes on time - Orders - Issued.

From the Managing Director, Tamil Nadu Water Supply and Drainage Board, letter No. 20614/ F.HLC – Line Department, JDO/M CWSS/2014, Dated 20.06.2014.

ORDER:

In the letter read above, the Managing Director, Tamil Nadu Water Supply and Drainage Board has stated that the Board is executing 14 Major Combined Water Supply Schemes, 27 Combined Water Supply Schemes, 35 Urban Standalone Water Supply Schemes, 18 Under Ground Sewerage Schemes at a total cost of Rs.6758.50 Crore. Most of the schemes executed by the Board have crossed their time line for completion due to inordinate delay in getting clearances from the Line Departments for the following:-

- i) Acquisition of land for construction of Sump, Wells, Service Reservoirs, Over Head Tanks etc.
- ii) Permission for Right of Way from State Highways, National Highways, National Highways Authority of India etc for laying pipelines
- iii) Permission of Railways for laying pipelines across railway tracks
- iv) Right of Way permission and acquisition of land from Forest Department.
- v) Permission for power supply connections from Tamil Nadu Generation and Distribution Corporation Limited
- vi) Environmental clearances for Sewerage Treatment Plant from Tamil Nadu Pollution Control Board.

2. The Managing Director, Tamil Nadu Water Supply and Drainage Board has stated that to implement the projects on time and to effect water supply and sewerage services to the general public, time taken to get clearance from Line Departments have to be reduced. He has, therefore, requested to constitute a "High Level Committee" with senior officers of the Departments concerned.

3. The Government after careful examination of the proposal of the Managing Director, Tamil Nadu Water Supply and Drainage Board, constitute a High Level Committee under the Chairmanship of the Chief Secretary to sort out the issues with the Line Departments for speedy implementation of Water Supply and Under Ground Sewerage Schemes with the following officials:-
