#### **ORDER:-**

The Honorable Chief Minister of Tamil Nadu has announced during the Collectors' conference held on 19.12.2012, vide Announcement No: 31, that "A Combined Water Supply Scheme would be provided to Kulithalai and Thogamalai areas at a cost of Rs.12.50 crore".

2. The Managing Director, Tamil Nadu Water Supply and Drainage Board in the letter read above has stated that Detailed Project Report has been prepared for providing Combined Water Supply Scheme to 253 Rural Habitations in Kulithalai and Thogamalai Unions in Karur District with River Cauvery as Source, at a cost of Rs.52.75 Crore (with HDPE pipe up to 200mm diameter) to install and Rs. 164.00 Lakh to maintain annually.

Based on the recommendation of the Tamil Nadu Water Supply and Drainage Board in its Resolution No.2.7, dated 31.1.2014, the Empowered Committee has RESOLVED to accord Administrative approval for providing Combined Water Supply Scheme to 253 Rural Habitations in Kulithalai and Thogamalai Unions in Karur District with River Cauvery as Source at a cost of Rs.52.75 Crore (with HDPE pipe up to 200mm diameter) to install and Rs. 164.00 Lakh to maintain annually and to be implemented through Tamil Nadu Water Supply and Drainage Board with 100% Grant under NRDWP /SMS.
- 4. Accordingly the Managing Director, Tamil Nadu Water Supply and Drainage Board has sent proposal to Government to issue necessary orders to implement the above scheme.
- 5. The Government after careful consideration accord Administrative Approval for providing Combined Water Supply Scheme to 253 Rural Habitations in Kulithalai and Thogamalai Unions in Karur District with River Cauvery as Source at a cost of Rs.52.75 Crore (with HDPE pipe up to 200mm diameter) to install and Rs. 164.00 Lakh to maintain annually and to be implemented through Tamil Nadu Water Supply and Drainage Board with 100% Grant under NRDWP /SMS.
