The Honourable Minister for Municipal Administration and Rural Development among others has announced on the floor of House during Demand No.34 for the year 2012-13 that the Combined Water Supply Scheme to Cuddalore, Virudhachalam Villupuram and Tindivanam Municipalities, 13 Town Panchayats and 3593 habitations in 26 Unions in Cuddalore and Villupuram Districts, with River Kollidam as source, would be taken up for implementation during 2012-13.

- 2. The Managing Director, Tamil Nadu Water Supply and Drainage Board in his letter read above, has stated that it has been programmed to take up the above Scheme in two Phases and Detailed Project Report covering Cuddalore Municipality, Bhuvanagiri Parangipettai Town Panchayats and 812 Rural habitations in Cuddalore District with source located in River Kollidam near Eyyalore had already been sanctioned at a cost of Rs.260.54 Crore vide G.O.Ms.No.10, (WS.4) Department, Municipal Administration and Water Supply Dated.28.01.2013 and implementation of the same is under progress.
- 3. The Managing Director, Tamil Nadu Water Supply and Drainage Board has further stated that a Detailed Project Report for Phase-II has been prepared by Tamil Nadu Water Supply and Drainage Board for the downsized proposal of providing Combined Water Supply Scheme to 3 Town Panchayats, 267 rural habitations in Cuddalore District, Villupuram Municipality-added area, 2 Town Panchayats and 569 Rural Habitations in Villupuram District, with River Kollidam at Sarukkai as source at a cost of Rs 621.00 crore to install and Rs.7.28 crore to maintain annually.

The Government after careful consideration, according Administrative Sanction for providing Combined Water Supply Scheme to 3 Town Panchayats, 267 rural habitations in Cuddalore District, Villupuram Municipality added area, 2 Town Panchayats and 569 Rural Habitations in Villupuram District, with River Kollidam at Sarukkai as source at a cost of Rs 621.00 crore (Rupees six hundred and twenty one crore only) to install and Rs.7.28 crore (Rupees seven crore and twenty eight lakh only) to maintain annually and to implement the scheme with the following funding pattern, through Tamil Nadu Water Supply and Drainage Board.
