ORDER:

In the G.O. first read above, a sum of Rs.30.40 crore has been sanctioned under Infrastructure and Amenities Fund for the construction of High Level Bridge at Simmakal Road to Goripalayam and ESI Hospital (Aruldasapuram) to Arapalayam in Madurai Municipal Corporation, as resolved in the State Infrastructure and Amenities Promotion Committee.

2. In the letter second read above, the Commissioner of Town and Country Planning has requested to release the above sanctioned amount from the Infrastructure and Amenities Fund for construction of High Level Bridge at Simmakal Road to Goripalayam and ESI Hospital (Aruldasapuram) to Arapalayam in Madurai Municipal Corporation.

3. After careful examination, the Government accept the proposal and decided to release the above sanctioned amount of Rs.30.40 crore (Rupees thirty crore and forty lakh only) for construction of High Level Bridge at Simmakal Road to Goripalayam and ESI Hospital (Aruldasapuram) to

Accordingly, a sum of Rs.12,16,00,000/- is released as Phase - I in the Financial year 2014-2015.

4. The amount sanctioned in para 3 above shall be debited into the following head of account:-

“2217. Urban Development - 05. Other Urban Development Schemes- 800. Other expenditure - Schemes in Twelfth Five year Plan - II State Plan - KA. Schemes implemented in Urban Local Bodies under Infrastructure and Amenities Fund - 09. Grants in Aid - 02. Grants for creation of Capital Assets”.

5. The expenditure sanctioned in para 4 above shall be adjusted under following head of account:-

“2217 - Urban Development - 05 - Other Urban Development Schemes - 902 - Deduct - Amount met from Infrastructure Development Fund - JC. Amount met from State Infrastructure and Amenities Fund - 30. Inter Account Transfers **(DPC: 2217-05-902-JC-3002)**

by contra debiting, “ J. Reserve funds (b) Reserve Funds not bearing interest - 8229-00. Development and Welfare Funds - 200. Other Development and Welfare Fund - AZ. State Infrastructure and Amenities

0-200-AZ-0005 (Outgo).

6. The expenditure sanctioned in para 3 above constitutes an item of "**New Instrument of Service**". The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by sanction of an advance from the Contingency Fund, orders regarding which will be issued by the Government in Finance (BG-I) Department separately. The Commissioner of Municipal Administration is directed to send necessary proposal to Government in Finance (BG-I) Department in the prescribed format along with a copy of this order for sanction of advance from Contingency Fund for the amount actually required to meet the expenditure immediately during the current financial year.

7. The concerned PAO / TO's are requested to make necessary adjustments entries at the end of the financial year 2014-2015.
