ORDER:

The Government of India have formulated the National Urban Health Mission (NUHM) to effectively address the health concerns of the urban poor population by facilitating equitable access to quality health care through a revamped public health system, partnerships and community health mechanisms with the active involvement of the urban local bodies. Government of India has launched the National Urban Health Mission (NUHM) as a Sub Mission of National Health Mission for taking care of primary health care needs of urban poor and informed that National Rural Health Mission (NRHM) and National Urban Health Mission (NUHM) are two distinct sub missions of National Health Mission. Government of India has suggested that for the Implementation of National Urban Health Mission (NUHM), the existing State Health Mission and State Health Society and the existing structure of the District Health Society/Mission under National Rural Health Mission may be reconstituted with additional stakeholders as members.

2) Government of India have also suggested that for the mega city, namely Chennai, National Urban Health Mission may be implemented through the respective local body. Therefore, the formation of Corporation Health Society with a Governing Body and Executive Committee under Tamil Nadu Societies Registration Act 1975 has been proposed for the Corporation of Chennai as per the Government of India guidelines. The Mission Director, National Rural Health Mission, Government of India has suggested among others, that the Minister in charge of Urban Development and

Housing and Secretaries of Urban Development and Housing Department may be nominated as members in the State Health Mission. Government of India suggested that the States may either decide to constitute a separate City Urban Health Mission / City Urban Health Society at the city level or use the existing structure of the District Health Society / Mission under NRHM with additional members for other corporations. In Tamil Nadu, except Chennai mega city, there are nine other Corporations under the control of the Commissioner of Municipal Administration. The Mission Director has suggested that a separate City Urban Health Mission / City Urban Health Society may be constituted under Tamil Nadu Societies Registration Act 1975 for Vellore, Madurai, Coimbatore, Thirupur, Tirunelveli, Salem, Tiruchirapalli, Thoothukudi and Erode Corporations. The Chairman and Members of the Governing Body and Executive Committee and financial and administrative power would be proposed by the Mission Director, State Health Society for the Corporation Health Society.

3. The Government, in G.O.Ms.No.309 Health and Family Welfare Department, dated 16.12.2005 have constituted State Health Mission, State Health Society, District Health Mission and the District Health Societies. The Mission Director, State Health Society has proposed for the inclusion of certain members in the State Health Mission and District Health Society. He has also suggested the members for inclusion in the State Health Mission, Governing Body and Executive Committee of the State Health Society, District Health Mission and Governing Body and Executive Committee of the District Health Society.

4) The Government of India have approved certain posts in PIP 2013-17 for strengthening the existing State Project Management Unit and District Project Management Units and to establish City Project Management Unit for Chennai Corporation and 9 Other Corporations to implement the National Urban Health Mission (NUHM) The Mission Director has stated that all the posts sanctioned under National Urban Health Mission (NUHM) may be filled up on deputation and wherever regular candidates are not available for deputation, retired persons / outsourced persons may be appointed on consolidated pay as per National Rural Health Mission / State Health Society prevailing norms. The expenditure towards staff will be incurred from the National Urban Health Mission funds.

5. Therefore, the Mission Director, State Health Society has requested the Government to issue orders for inclusion of Members in the State Health Mission and Governing Body & Executive Committee of the State Health Society, District Health Mission and Governing Body & Executive Committee of the District Health Society and also requested that all the posts sanctioned under National Urban Health Mission (NUHM) will be filled up on deputation and wherever regular candidates are not available for deputation, retired persons / outsourced persons will be appointed on consolidated pay as per National Rural Health Mission / State Health Society prevailing norms and expenditure towards staff will be incurred from the National Urban Health Mission funds.

6) The Government, after careful examination, have decided to accept the proposal of the Mission Director, State Health Society and accordingly issue orders as follows:

- I. The Mission Director, State Health Society is nominated as Mission Director for State Health Mission and Executive Secretary, State Health Society, Tamil Nadu to co-ordinate the activities under National Rural Health Mission and National Urban Health Mission.
- II. The State Health Mission, Governing Body and Executive Committee of the State Health Society, District Health Mission and Governing Body and Executive Committee of the District Health Society is reconstituted with additional members as proposed by the Mission Director, State Health Society as in the Annexure - I to this order.
- III. Corporation Health Society with a Governing body and Executive Committee is formed for the Chennai Corporation and nine other Corporations with the members as proposed by the Mission Director, State Health Society as in the Annexure -II to this order.
- IV. The existing State Programme Management Unit and District Project Management Units are strengthened with additional posts and the City Project Management Unit is formed for the Chennai Corporation and nine other Corporations with the posts sanctioned by the Government of India as indicated in the Annexure -III to this order.
- V. The appropriate annual expenditure of Rs.79.0 lakhs towards sanction of the said posts will be met from the National Urban Health Mission (NUHM) funds.

There would be no expenditure to the State Government.
