ORDER:

Accordingly, she has assumed charge of the post of Faculty (Public Health), Tamil Nadu Institute of Urban Studies, Coimbatore on Foreign Service on 19.12.2016 Fore Noon and her first year deputation period expired on 18.12.2017.

In the Government Order second read above, orders were issued extending the deputation of Dr.P.Aruna, Deputy Director of Public Health and Preventive Medicine Grade-II as Faculty (Public Health), Tamil Nadu Institute of Urban Studies, Coimbatore for a further period of one year (i.e.second year) with above said terms and conditions and her deputation period of second year was expired on 18.12.2018.
