| Special Grade | Exceeding rupees ten crores |
| Selection Grade | Exceeding rupees six crores and not exceeding rupees ten crores |
| First Grade | Exceeding rupees four crores and not exceeding rupees six crores |
| Second Grade | Not exceeding rupees four crores |

4. The Commissioner of Municipal Administration in his letter second read above, has sent proposal for the upgradation of Ramanathapuram First Grade Municipality as Special Grade Municipality and he has stated that the economic and other factors of Ramanathapuram First Grade Municipality satisfies the norms relating to population, income, in terms of sub-section (6) of section 4 of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920).

5.
