ORDER:

The Swarna Jayanthi Shahari Rozgar Yojana has now been restructured as the National Urban Livelihoods Mission (NULM) w.e.f 3rd September 2013. The scheme for Support to Urban Street Vendors (SUSV) has been included as part of the component under NULM.

2. The objectives of the Support to Urban Street Vendors (SUSV) under the component of National Urban Livelihoods Mission are (i) Survey of street vendors and issue of Identity Cards (ii) Development of city street vending plans (iii) Infrastructure development of vending zones in the city (iv) Training and Skill Development (v) Financial Inclusion (vi) Access to credit (vii) Linkages to social security schemes.

3. In order to appraise and approve the proposal submitted by the Urban Local Bodies under the Support to Urban Street Vendors component of National Urban Livelihoods Mission, a Project Sanctioning Committee needs to be constituted

at the State Level under the Chairmanship of Principal Secretary/Secretary in-charge of NULM with representatives of all concerned departments in the State. As per the guidelines, a representative from the Ministry of Housing and Urban Poverty Alleviation shall also be a member of this Sanctioning Committee.

4. The Commissioner of Municipal Administration has suggested the composition of the State Projects Sanctioning Committee and requested approval of the Government. The Government after careful examination accept the proposal of Commissioner of Municipal Administration and accordingly, constitute the State Project Sanctioning Committee for consideration and approval of proposals submitted by the Urban Local Bodies/State Urban Livelihoods Mission under the component of Support to Urban Street Vendors (SUSV) of the National Urban Livelihoods Mission, as follows:
