### **ORDER:**

During the Budget Speech for the year 2015-16 has Announced on the floor of the Legislative Assembly that the existing Fish Market in 19 Districts of Tamil Nadu will be modernized.

2. The Commissioner of Fisheries in her letter read above has sent necessary proposals to implement the above announcement.

3. The Commissioner of Fisheries has also stated that a proposals for Construction / Modernization of Fish Market in selected places have been obtained from the concerned Municipalities / Co-operative Fishermen Society / Fisheries Department and the same has been sent to National Fisheries Development Board (NFDB) for seeking financial assistance at 40% of the Total Project Cost. The Balance 60% has to be

met out by State Government and Local Body to construct the Fish Markets.

4. The Commissioner of Fisheries has also stated that in the first phase, the National Fisheries Development Board (NFDB) has sanctioned 2 proposals and has Released Rs.8.572 lakh as its share. The details are as follows:-

5. The Commissioner of Fisheries has also stated that in order to implement the announcement made 24 proposals for Construction/Modernization of Fish Markets which are owned by various Civic Bodies / Fishermen Co-operative societies were sent to National Fisheries Development Board (NFDB) for obtaining Financial Assistance. Subsequent to which the National Fisheries Development Board (NFDB) sanctioned 40% funding for the following 15 proposals in second phase for a Total Amount of



Rs.442.37 lakh (Rupees four hundred forty two lakh and thirty seven thousand only) as follows : -

It is also stated that the Civic Bodies / Fishermen Co-operative Societies who owns and maintains the Fish Markets excepting Sl.No.5 and Sl.No.9 of the above table have consented to provide 10% of the project cost from its own source. In respect of Sl.No.5, Nagapattinam Town Fish Market which is owned by the Department of Fisheries. The remaining 60% of the project cost is requested from Government, whereas Sl.No.9 ie., Kasi Vilngai Fish Market, Woraiyur, the Tiruchirapalli Corporation has consented to bear the reaming 60% of the project cost from its own fund. Hence no grant is required from the Government.

6. The Commissioner of Fisheries has further stated that considering the financial constraints faced by most of the Civic Bodies / Fishermen Co-operative Societies, in Developing Hygienic Modern Whole Sale / Retail Fish Market has requested the Government to sanction a sum of Rs.432.24 lakh (Rupees four hundred thirty two lakh and twenty four thousand only) (ie., Government grant 50%) as Financial Assistance so as to implement the Announcement made by the Government.

7. The National Fisheries Development Board (NFDB) has provided administrative approval for Rs.1105.93 lakh for Construction/ Modernization of 15 Fish Markets and Financial Assistance of Rs.442.37 lakh which are owned by Civic Bodies / Fishermen Co-operation Societies in various District of Tamil Nadu. The National Fisheries Development Board (NFDB) has also released a sum of Rs.62.47 lakh as first installment. But the commissioner of Fisheries has now requested the Government to Sanction an Amount of Rs.432.24 lakh as Financial Assistance to 15 Fish Markets i.e. State Government Share.

8. The Government examined the proposal of the Commissioner of Fisheries and accord administrative approval for a sum of Rs.1105.93 lakh (Rupees Eleven crore five lakh and ninety three thousand only) based on the sanction made by the National Fisheries Development Board (NFDB) for Modernization of Fish Markets in various Districts and also release a sum Rs.70.34 lakh (Rupees Seventy lakh and thirty four thousand only) as first installment of the proportionate share of the State Government as detailed in Annexure to this order.

9. The expenditure sanctioned in the para 8 above shall be debited to the following Head of Account:-

"2405-00 Fisheries - 105, processing, preservation and Marketing - I. Non-Plan-AI.Transport of Fish to Marketing Centres -11 Subsidies - 01 Individual Based Subsidy".

10. Necessary Funds will be provided in RBE 2016-2017.

11. The Commissioner of Fisheries is authorized to draw and disburse the amount sanctioned in para 8 to the respective civic bodies/owner of fish markets.

1. For Fish Markets mentioned in Sl.No.3,4,7 the NFDB has released 50% of the Amount from its 40% share and for the remaining Fish Markets the NFDB released 10% amount from its 40% share of the project cost.
2. In respect of Sl.No.5, i.e., Nagapattinam Town Fish Market an amount of Rs.6.83 lakh has been proposed since, the Market is owned by Fisheries Department (Beneficiary contribution of 10% - Rs.4.27 lakh + proportionate release amount by the Government - Rs.2.56 lakh)
3. For Sl.No. 9 i.e. Kasi Vilangai Fish Market at Trichy, no grant is requested. Since, the Municipal Corporation, Trichy has given consent to bear the 60% Project cost from its own fund.
