ORDER:

Under the award of 13th Central Finance Commission, a total sum of Rs.4907.36 lakhs sanctioned by Government of India as General Performance Grants to the Municipal Corporations, Municipalities and Town Panchyats of this State has been released vide the Government Orders first to fourth read above.

2. The Joint Director, Finance Commission Division, Department of Expenditure, Ministry of Finance in the letter fifth read above, has conveyed the approval of the Government of India for payment of Rs.5309.34 lakhs as General Performance Grant to the urban local bodies of this State for the year 2014-15 under the award of the 13th Central Finance Commission

forfeited by non-performing States to performing and non-performing State (s).

3. Accordingly, the Government sanction a sum of Rs.37,69,63,140/-to the Corporations and Municipalities and a sum of Rs.15,39,70,860/- to the Town Panchayats totalling a sum of Rs.53,09,34,000/- (Rupees Fifty three crore nine lakh and thirty four thousand only) to the Corporations, Municipalities and Town Panchayats as General Performance Grants under the award of 13th Central Finance Commission as below:
