ORDER:

In the Government Order first read above, the Government have ordered to issue Free Birth Certificate for the deliveries occurring in the Government Hospitals on the same day or prior to the discharge of the mothers from the Hospitals under section 12 of the Registration of Births and Deaths Act, 1969 (Central Act 18 of 1969).

2. In the Government Order second read above, the Government have issued orders to appoint the Health Inspectors working in the Primary Health Centers as Registrar under the said Registration of Births and Deaths Act, 1969 for the areas in which respective Primary Health centers are situated.

3. In the letter third read above, the Director of Public Health and Preventive Medicine has requested the Government to declare the registration centers already established in the District Head Quarters Hospitals and Medical College Hospitals as ordered in the Government order first read above in the State as registration units for the vital events occurring in those institutions to facilitate the complete coverage of the large number of births and deaths taking place in the institution and to appoint the Multipurpose Health Supervisors (Male) (formerly Health Inspectors) as Births and Deaths Registrars for the registration units in the Government District Head Quarters Hospitals and Medical College Hospitals under section 7(1) of the said Registration of Births and Deaths Act, 1969.

4. The Government have examined the proposal of the Director of Public Health and Preventive Medicine and decided to appoint the Multipurpose Health Supervisors (Male) (formerly Health Inspectors) as Births and Deaths Registrars for the Government

District Head Quarters Hospitals, Government Medical College Hospitals, Taluk and Non-Taluk Hospitals situated in Rural areas (Village Panchayats) and Sanitary Inspectors / Executive Officers of Urban Local Bodies and Town Panchayats as Births and Deaths Registrars for the Government District Head Quarters Hospitals and Government Medical College Hospitals, Taluk and Non-Taluk Hospitals situated in Urban areas and Town Panchayats under section 7(1) of the Registration of Births and Deaths Act, 1969 with effect from the date of publication of the notification appended to this order in the Tamil Nadu Government Gazette.

5. The appended Notification will be published in the Tamil Nadu Government Gazette.
