#### **ORDER:**

In the Government Order first read above, the Government have notified the Tamil Nadu Urban Infrastructure Financial Services Limited (TNUIFSL) as optional consultancy providing/procuring agency under the Tamil Transparency Tenders Act, 1998 subject to the condition that in each case the Government will fix the consultancy fee wherein the Tamil Nadu Urban Infrastructure Financial Services Limited itself carried out the consultancy and service charges in case external consultancy agency is procured by TNUIFSL.

2. The Member-Secretary, Chennai Metropolitan Development Authority in his letter 2<sup>nd</sup> read above has stated that it was decided in the High Power Committee meeting for the Chennai Metro Rail Limited (CMRL) project held on 14.02.2012 that a study on "Densification along the CMRL Corridors" may be taken up. Tamil Nadu Urban Infrastructure Financial Services Limited who was asked to engage consultant to take up the study has requested Chennai Metropolitan Development Authority to pay a service charge of 5% on the quoted bid cost by the consultant. He has therefore sent the proposal to Government for approval in compliance with the orders of the Government issued in the Government Order first read above.

3. The Government have examined the request of Member-Secretary, Chennai Metropolitan Development Authority and he is permitted to incur the expenditure of 5% service charge on the quoted bid cost by the consultant to the TNUIFSL, from the funds of Chennai Metropolitan Development Authority.
