**ORDER:**

In the reference cited the Commissioner of Municipal Administration has stated that at present there are 24 Selection Grade Municipal Commissioners are vacant. The Municipal Commissioners being the sanction Authorities for Urban Local Bodies, their services are very much essential for day to day administration and for implementing the State and Central Schemes and monitor the progress of schemes to Municipalities. Further, he has stated that the Municipal Election will be held in ensuing months and the Municipal Commissioners are Returning Officers of the respective Municipalities. Hence, to conduct the Municipal Elections properly, the role of Municipal Commissioners are very vital. Therefore, the Commissioner of Municipal Administration has requested the Government to promote temporarily for the following Municipal Commissioner, Grade-I as Selection Grade Municipal Commissioners under section 47(1) of Tamil Nadu Government Servants (Conditions of Service) Act:-

2. The proposal of the Commissioner of Municipal Administration has been examined carefully. The individuals mentioned in Sl.No.1 to 3 at para 1 above have completed their probation period of two years in the post of Municipal Commissioner, Grade I as on date and the rest of the individuals mentioned in Sl.No.4 to 18 above have not completed their probation period of two years in the post of Municipal Commissioner, Grade I. However, considering the huge number of vacancies in the post of Commissioner of Municipalities filling up of those posts are very essential in view of North-East Monsoon, Anti-Dengue drive, upcoming Local Body elections and other reasons mentioned by the Commissioner of Municipal Administration. Therefore, by invoking the proviso to section 58 of Tamil Nadu Government Servants (Conditions of Service) Act, 2016, the Government hereby relax the rule 5 of Tamil Nadu Municipal Commissioners Service Rules (i.e. probation period of two years in Municipal Commissioner, Grade I) as one time measure for the following 15 Municipal Commissioner, Grade I for temporary promotion under Section 47(1) of Tamil Nadu Government Servants (Conditions of Service) Act, 2016 as Selection Grade Municipal Commissioners:-
