## **APPENDIX**

### **NOTIFICATION**

In exercise of the powers conferred by section 1 of the Tamil Nadu Districts Limits Act, 1865 (Tamil Nadu Act 1 of 1865), the Governor of Tamil Nadu hereby directs that with effect on and from 12<sup>th</sup> November 2019.

(i) Vellore District is trifurcated into Vellore, Tirupathur and Ranipet Districts as follows:-

- a. Vellore District with Head Quarters at Vellore.
- b. Tirupathur District with Head Quarters at Tirupathur.
- c. Ranipet District with Head Quarters at Ranipet.

(ii) The two Revenue Divisions of Vellore & Gudiyatham (new) and six Revenue Taluks of Vellore, Anaicut, Katpadi, Gudiyatham, Pernambut & K.V.Kuppam (new) shall constitute Vellore District.

(iii) The two Revenue Divisions of Tirupathur & Vaniyambadi (new) and four Revenue Taluks of Tirupathur, Vaniyambadi, Natrampalli & Ambur shall constitute Tirupathur District.

(iv) The two Revenue Divisions of Ranipet & Arakkonam (new) and four Revenue Taluks of Walajah, Arcot, Nemili & Arakkonam shall constitute Ranipet District.

**ORDER:**

The Hon'ble Chief Minister during the 73<sup>rd</sup> Independence day celebrations held on 15.08.2019, has made the following announcement:-

***"For administrative convenience, considering the representations received from the Hon'ble Ministers, Members of Legislative Assembly and the General Public, Vellore District will be trifurcated into Tirupathur, Ranipet Districts with its Head Quarters at Tirupathur and Ranipet respectively and new K.V.Kuppam Taluk will be formed".***

2. Based on the above announcement, the Additional Chief Secretary / Commissioner of Revenue Administration has visited Vellore on 29.08.2019 & 30.08.2019 and held a detailed discussions with the Hon'ble M.P. and M.L.A.'s, District Collector, Vellore Elected Representatives, Leaders of political parties and all sections of people, has sent necessary proposals and requested the Government to issue necessary orders.

3. The Government have examined the proposal of the Additional Chief Secretary / Commissioner of Revenue Administration in detail and pass the following orders:-

- (i) The Vellore District is trifurcated into Vellore, Tirupathur and Ranipet as follows:-
  - a. Vellore District with its Head Quarters at Vellore.
  - b. Tirupathur District with its Head Quarters at Tirupathur.
  - c. Ranipet District with its Head Quarters at Ranipet.

- (ii) The Jurisdiction of Vellore District, Tirupathur and Ranipet new Districts (Details are indicated in Annexure - I to this order).
- (iii) K.V.Kuppam new Taluk is formed with its Head Quarters at K.V.Kuppam by including 2 Firkas (44 Revenue Villages) viz., K.V.Kuppam (19 Villages) and Vaduganthangal (25 Villages) under Gudiyatham Revenue Division in Vellore District. (Details are indicated in Annexure - II to this order).
- (iv) Gudiyatham new Revenue Division is formed with Head Quarters at Gudiyatham by including 3 Taluks (137 Revenue Villages) viz., Pernambut (32 Villages), restructured Gudiyatham (61 Villages) and K.V.Kuppam(new) (44 Villages) in Vellore District.
- (v) Vaniyambadi new Revenue Division is formed with Head Quarters at Vaniyambadi by including 2 restructured Taluks (95 Revenue Villages) viz., Vaniyambadi (41 Villages) and Ambur (54 Villages) in Tirupathur new District.
- (vi) Arakkonam new Revenue Division is formed with Headquarters at Arakkonam by including 2 restructured Taluks (145 Revenue Villages) viz., Arakkonam (64 Villages) and Nemili (81 Villages) in Ranipet new District.
- (vii) 8 Revenue Villages are merged from Gudiyatham East Firka to K.V.Kuppam Firka in K.V. Kuppam new Taluk and to retain 18 Revenue Villages in the Gudiyatham East Firka in Gudiyatham Taluk.
- (viii) Gudiyatham Taluk is restructured with 3 Firkas (61 Revenue Villages) viz., Gudiyatham East (18 Villages), Gudiyatham West (20 Villages) and Valathur (23 Villages) under Gudiyatham Revenue Division in Vellore District.
- (ix) Katpadi Taluk is restructured with 3 Firkas (49 Revenue Villages) viz., Katpadi (13 Villages), Thiruvalem (15 Villages) and Melpadi (21 Villages) under Vellore Revenue Division in Vellore District.
- (x) Tirupathur Taluk is restructured with 6 Firkas (70 Revenue Villages) viz., Tirupathur (14 Villages), Koratti (15 Villages), Kandili (23 Villages), Jolarpet (8 Villages), Pudurnadu (3 Villages) and Andiyappanur (7 Villages) under Tirupathur Revenue Division in Tirupathur new District.

- (xi) Vaniyambadi Taluk is restructured with 3 Firkas (41 Revenue Villages) viz., Vaniyambadi (16 Villages), Ambalur (15 Villages) and Alangayam (10 Villages) under Vaniyambadi Revenue Division in Tirupathur new District.
- (xii) Ambur Taluk is restructured with 4 Firkas (54 Revenue Villages) viz., Ambur (14 Villages), Madhanur (10 Villages), Melsanangkuppam (16 Villages) and Thuthipattu (14 Villages) under Vaniyambadi Revenue Division in Tirupathur new District.
- (xiii) Tirupathur and Vaniyambadi Taluks are restructured with Andiyappanur Firka in Tirupathur Taluk. 7 Revenue Villages in Andiyappanur Firka except Chinnaveppampattu Village is added with Tirupathur taluk and also Chinnaveppampattu village is added with Vaniyambadi Firka in Vaniyambadi Taluk.
- (xiv) Nemili Taluk is restructured with 4 Firkas (81 Revenue Villages) viz., Banavaram (17 Villages), Kaveripakkam (19 Villages), Panapakkam (26 Villages), Nemili (19 Villages) under Arakkonam Revenue Division in Ranipet new District.
- (xv) Arakkonam taluk is restructured with 4 Firkas (64 Revenue Villages) viz., Arakkonam South (17 Villages), Arakkonam North (14 Villages), Pallur (10 Villages), Paranj (23 Villages) under Arakkonam Revenue Division in Ranipet new District.
- (xvi) Ranipet Revenue Division is restructured with 2 taluks (185 Revenue Villages) viz., Walajah (83 Villages) and Arcot (102 Villages) in Ranipet new District.

4. The District Collector, Vellore District and the Special Officers of Tirupathur and Ranipet new Districts are requested to take immediate action to give effect to this order.

5. The Principal Secretary / Commissioner of Revenue Administration is requested to send necessary proposals of recurring and non-recurring expenditure and creation of staff for the creation of Tirupathur and Ranipet Districts, K.V.Kuppam Revenue Taluk and Vaniyambadi, Arakkonam & Gudiyatham Revenue Divisions.

6. The details of recurring and non-recurring expenditure and creation of posts for newly created Tirupathur and Ranipet Districts, K.V.Kuppam Revenue Taluk and Vaniyambadi, Arakkonam & Gudiyatham Revenue Divisions, necessary orders will be issued separately.



7. The delimitation of the territorial wards of Village Panchayats, Panchayat Union and District Panchayats have already been notified under the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994) and thereby the delimitation exercise for the ensuing local body elections has already been completed. Notwithstanding the notification to bifurcate the districts, the process started already to conduct the ensuing Local Body Elections will be continued as per the order of the Hon'ble Supreme Court dated 17.07.2019 in W.P.(Civil) No.1267/2018. After the ensuing Local Body Elections, the process of modification if any, with regard to local bodies will be taken up by the Government.
