ORDER:

In the Government Order first read above, the Government sanctioned a scheme for grant of House Building Advance to Municipal Employees. The Director of Municipal Administration has proposed that the Tamil Nadu Government Employees House Building Advance-Special Family Benefit Fund Scheme be extended to the Municipal Employees also.

2. The Government examined the matter in consultation with the Director of Municipal Administration, the Director of Treasuries and Accounts and the Examiner of Local Fund Accounts and have decided to accept the proposal of the Director of Municipal Administration. The Government accordingly direct that the Tamil Nadu Government Employees House Building Advance-Special Family Benefit Fund Scheme sanctioned in the G.O. second read above and the rules issued in the matter in G.O. third read above, as amended from time to time, be extended to the Municipal Employees to whom House Building Advance is sanctioned under the scheme sanctioned in the G.O. first read above with effect from the date of the order from 21.9.94.

3. The Director of Municipal Administration is requested to issue a detailed further instructions to the Commissioners of the Municipalities and the Corporations of Tiruchy, Salem and Tirunelveli in consultation with the Director of Treasuries and Accounts, Madras 35 by suitably incorporating the procedure as ordered in G.Os. 2nd and 3rd read above.
