ORDER:

In the letter 10th read above the Commissioner of Municipal Administration has stated that the Sanitary Officer posts have been created in the Municipalities under Tamil Nadu Municipal Service and also in the Chennai Corporation by surrendering the equal number of Sanitary Inspectors posts. As proposed by the Commissioners of Madurai, Tirunelveli, Thoothukudi, Tiruppur, Vellore, Tiruchirappalli, Erode, Coimbatore and Salem Corporations one post of p.t.o.

Sanitary Officer per zone may be created by surrendering equal number of post of Sanitary Inspector in order to have uniformity and has informed that the percentage of expenditure on pay and pension charges is within 49% in these Corporations.

2) The Commissioner of Municipal Administration has also stated that the qualification for the post of Sanitary Officer is one and the same as of the Sanitary Inspector. Promotion to the post of Sanitary Officer shall be made from the Sanitary Inspectors as per the seniority. Each Corporation is a separate unit and Corporation wise seniority list of Sanitary Inspectors is available. The pay for the post of Sanitary Officer is Rs.9300 – 34800 + G.P.4500 and Sanitary Inspector is Rs. 9300 – 34800 + G.P.4200. The additional expenditure for creation of these posts will be met out from the Corporation General Fund and no Government fund is involved.

3) The Commissioner of Municipal Administration has further stated that except in Coimbatore Corporation, in all other Corporations there are 4 zones. In Coimbatore Corporation there are 5 zones. Therefore, the Commissioner of Municipal Administration has requested for the creation of 37 Sanitary Officer posts in 9 Corporations viz., Madurai, Tirunelveli, Thoothukudi, Tiruppur, Vellore, Tiruchirappalli, Erode, Coimbatore and Salem by surrendering the same number of Sanitary Inspector post.

4) The Government after careful examination, have decided to accept the proposal of the Director of Municipal Administration and accordingly create 37 posts of Sanitary Officers by upgrading equal number of posts of Sanitary inspectors in the respective Corporations so as to create a middle level competent authority in the Public Health Wing of 9 Corporations (Viz., Madurai, Tirunelveli, Thoothukudi, Tiruppur, Vellore, Tiruchirappalli, Erode, Coimbatore and Salem) in the scale of pay of Rs.9300 – 34800 + G.P. 4500.
