In the Government order 1<sup>st</sup> read above, orders were issued for implementation of "Own Your Housing Scheme" for Government officials / employees in Nerkundram phase I scheme with certain guidelines.

- 2. In the Government order second and third read above, various amendments were issued to the guidelines already prescribed for allotment of houses under the scheme.
- 3. In the Government order fourth read above, orders were issued for enhancing the House Building Advance from Rs.25 lakhs to Rs.40 lakhs in respect of State Government Employees and from Rs.40 lakhs to Rs.60 lakhs in respect of All India Service Officers.
- 4. The Government examined the requests of the Associations to avail benefits from the Tamil Nadu Housing Board under "Own your Housing Scheme" carefully and decided to accept it. Accordingly sanction is accorded for additional House Building Advance of Rs.10 lakhs for the State Government Employees and Rs.20 Lakhs for the All India

Service Officers at the same terms and conditions of the House Building Advance for those officers who avail House Building Advance under the enhanced rates, and shall be paid to Tamil Nadu Housing Board towards the last instalment to be paid by the allottee Officers. The head of account for the loan outgo and remittance by Tamil Nadu Housing Board respectively will be indicated as and when required.

5. This orders issues with the concurrence of Finance Department vide its U.O.No.33/SS(PK)/2021, Finance (Hg.&UD.) Department, Dated 01.02.2021.
