ORDER:-

In the Government Order first read above, orders have been issued prescribing the following norms for classification of Municipalities:-

Sl.No. (1)	Grade (2)	Average Annual Income (3)
1	Special Grade Municipality	Exceeding rupees ten crores
2	Selection Grade Municipality	Exceeding rupees six crores and not exceeding rupees ten crores
3	First Grade Municipality	Exceeding rupees four crores and not exceeding rupees six crores
4	Second Grade Municipality	Not exceeding rupees four crores.

2. In the letter Second read above, the Director of Municipal Administration has informed that, the devolution of financial grants are increasing every year and in view of the inflation, average annual income has also increased considerably. Further, the powers of various authorities and officials of the Urban Local Bodies have been enhanced to facilitate speedy planning and execution of development schemes. Therefore, the revision of norms for classification of Municipalities and consequent upgradation of Municipalities are essential.

3. The Director of Municipal Administration has therefore requested the Government to revise the norms for classification of Municipalities on the basis of the Average annual income, as below:-

Sl.No.	Grade	Average Annual Income	
		Existing	Proposed (50% annual increment)
1	Special	Exceeding Rs.10.00 crores	Above Rs.15.00 crores
2	Selection	Exceeding Rs.6.00 crore and not exceeding Rs.10.00 crores	Above Rs.9.00 crores and below Rs.15.00 crores
3	First	Exceeding Rs.4.00 crores and not exceeding Rs.6.00 crores	Above Rs.6.00 crores and below Rs.9.00 crores
4	Second	Not exceeding Rs.4.00 crores	Below Rs.6.00 crores

4. Accordingly, the Government after careful examination of the proposal of the Director of Municipal Administration have decided to accept the same and accordingly direct that the norms for classification of municipalities, shall be revised as below:-

Sl.No. (1)	Grade (2)	Average Annual Income (3)
1	Special Grade Municipality	Exceeding rupees fifteen crores
2	Selection Grade Municipality	Exceeding rupees nine crores and not exceeding rupees fifteen crores
3	First Grade Municipality	Exceeding rupees six crores and not exceeding rupees nine crores
4	Second Grade Municipality	Not exceeding rupees six crores.

5. Accordingly, rule 3 of the Tamil Nadu Municipalities (Norms for Classification of Municipalities) Rules, 2008 shall be amended suitably, as in the appended notification.
