ORDER:

In the Government Order first read above, orders have been issued fixing the total number of Councillors to be elected to the councils of the City Municipal Corporations and Municipalities.

- **2.** In the Tamil Nadu Ordinances second and third read above, the Sivakasi (including Thiruthangal) Municipality and the expanded Tambaram Municipality have been Constituted as City Municipal Corporations with effect on and from 21.10.2021 and 03.11.2021, respectively.
- 3. In the Government Order fourth read above, nine Town Panchayats, namely Surandai, Kalakkadu, Thirukovilur, Ulundurpet, Mangadu Kottakuppam, Sholingur and Nandhivaram-Kundrathur, Guduvancheri have been constituted as Municipalities. Similarly, in the Government Orders fifth to seventh read above, nineteen Town Thirunindravur, Tittakudi, Ponneri, namely Panchavats, Adirampattinam, Tiruchendur, Karumathampatti, Karamadai, Gudalur, Thirumuruganpoondi, Manamadurai, Lalgudi, Madukkarai, Pallapatti, Musiri, Tharamangalam, Edanganasalai, Kollencode and Pugalur have been constituted as Municipalities.
- **4.** In the Government order eighth read above, the Nagercoil City Municipal Corporation has been expanded with the inclusion of Aloor and Thengamputhur Town Panchayats.
- **5.** As per section 5 (1) of the Sivakasi and Tambaram City Municipal Corporation Ordinances, 2021, the Council shall consists of such number of Councillors as may be fixed by the Government, by Notification, from time to time. However, the total number of Councillors of the Council should not exceed 72 (seventy two), at any time.
- **6.** Based on this, in the letter ninth read above, the Government have requested the Tamil Nadu Delimitation Commission to fix the strength of the Council for the above said newly Constituted/expanded Municipal Corporations and Municipalities as per section 4(1)(a) of the Tamil Nadu Delimitation Commission Act, 2017 (Tamil Nadu Act 23 of 2017).
- **7.** In the letter tenth read above, the Member-Secretary, Tamil Nadu Delimitation Commission, has sent the following recommendation of the Commission regarding fixation of the strength of the Councils, to the Government:—

In exercise of the powers conferred by sub-section (1) of section 5 of the Sivakasi City Municipal Corporation Ordinance, 2021 (Tamil Nadu Ordinance 3 of 2021), the Governor of Tamil Nadu, hereby fixes the number of councillors to be elected to the council of the Municipal Corporation of Sivakasi as forty eight (48), with effect on and from the next ordinary election.

NOTIFICATION-II.

In exercise of the powers conferred by sub-section (1) of section 5 of the Tambaram City Municipal Corporation Ordinance, 2021 (Tamil Nadu Ordinance 5 of 2021), the Governor of Tamil Nadu, hereby fixes the number of councillors to be elected to the council of the Municipal Corporation of Tambaram as seventy (70), with effect on and from the next ordinary election.

NOTIFICATION-III.

In exercise of the powers conferred by sub-section (1) of section 5 of the Nagercoil City Municipal Corporation Act, 2019 (Tamil Nadu Act 11 of 2019), the Governor of Tamil Nadu, hereby fixes the number of councillors to be elected to the council of the Municipal Corporation of Nagercoil as fifty two (52), with effect on and from the next ordinary election.

NOTIFICATION-IV.
