2. The Government, after careful examination of the above proposal, have decided to accept the same and notify the reservation for the persons belonging to the Scheduled Castes (General), Scheduled Castes (Women) and for Women (General) in the offices of Mayor of Municipal Corporations.

3. Accordingly, the appended Notification will be published in the *Tamil Nadu Government Gazette* Extraordinary, dated the 17th January 2022.
