ORDER:

The Ministry of Housing and Urban Affairs, Government of India has launched its flagship programme, namely, "Atal Mission for Rejuvenation and Urban Transformation 2.0" (AMRUT 2.0) on 01.10.2021. The key components of the Atal Mission for Rejuvenation and Urban Transformation 2.0 are (a) Universal coverage of water supply; (b) Sewerage, Septage management and recycle / reuse of treated used water; (c) Rejuvenation of water bodies (including urban wet lands) and creation of green spaces.

2. Administrative Sanction for implementation of Atal Mission for Rejuvenation and Urban Transformation 2.0. has been accorded and the State High Powered Steering Committee (SHPSC) headed by the Chief Secretary to Government has been constituted for the approval of

the Projects under the Mission, vide the Government Order first read above.

3. In the letter third read above, the Mission Director, Atal Mission for Rejuvenation and Urban Transformation and the Additional Chief Secretary / Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has stated that, the State High Powered Steering Committee (SHPSC) of Atal Mission for Rejuvenation and Urban Transformation 2.0 during its 4th meeting held on 14.09.2022 vide the minutes 2nd read above, among others, has approved 38 projects of 'Development of green spaces / parks' in 3 Town Panchayats and 35 Municipalities (Details are given in Annexure) at an appraised project cost of Rs.12.33 crore under Atal Mission for Rejuvenation and Urban Transformation 2.0 Tranche-II FY 2022-23, as given in the Table below:
