ORDER

In Government Order first read above, orders have been issued for creation and allocation of fund/special fund for road development in urban areas viz., Corporations, Municipalities and Town Panchayats and also accorded in-principle approval to the proposal of the Principal Secretary/Commissioner, Greater Chennai Corporation, Commissioner of Town Panchayats and Director Municipal Administration for upgradation/improvement of roads. The Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited (TUFIDCO) has been nominated as Nodal Agency for administration of funds. The Nodal Agency was requested to formulate the guidelines on fund release, selection and approval of road works.

- 2. In Government Order first read above, orders have also been issued to release Rs.550 crore per year for the next four financial years, i.e., financial year 2022-23 onwards to the special fund for road development through Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited. The total liability to the Government in this special fund shall be restricted to Rs.2,200/- crore.
- 3. The amount allocated under the special fund will be provided to various urban local bodies of Tamil Nadu as given in the table 1.

- 4. In Government Order second read above, orders have been issued for approval of guidelines formulated by the Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited for implementation of "Nagarpura Salai Mempattu Thittam (Special Fund)" and concerned authorities have also been requested to adhere to the guidelines for implementing the road works / projects.
- **5.** Further, in Government Order second read above, a State level Project Sanctioning and Monitoring Committee has been constituted for the sanction of road projects to the urban local bodies, based on the appraisal done by the Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited.
- **6.** In Government Order third read above, based on the approval of the first Project Sanctioning and Monitoring Committee, administrative sanction was accorded for laying of 1,408 roads (black top, cement concrete and inter locking paver roads) at a cost of Rs.162.69 crore (Special Fund for road development Rs.151.00 crore + Greater Chennai Corporation share Rs.11.69 crore) under "Nagarpura Salai Mempattu Thittam" in Greater Chennai Corporation for the financial year 2022-23.
- 7. In Government Order fourth read above, based on the approval of the second Project Sanctioning and Monitoring Committee, administrative sanction was accorded for the following projects viz.,
- ➤ Greater Chennai Corporation (FY 2023-24) Laying of 228 roads (black top, cement concrete and inter locking paver roads) at a cost of Rs.31.26 crore (Special Fund for road development – Rs.29.49 crore + Greater Chennai Corporation share – Rs.1.77 crore) under "Nagarpura Salai Mempattu Thittam".

Director of Municipal Administration - FY -(2022-23)

Laying of 4,485 roads (black top, cement concrete and paver block roads) in corporations and municipalities at a cost of Rs.266.39 crore under Nagarpura Salai Mempattu Thittam (Special fund).

Director of Town Panchayats - FY-(2022-23 & 2023-24)

Laying of 1,490 roads (black top, cement concrete and paver block roads) in various town panchayats at a cost of Rs.155.25 crore under Nagarpura Salai Mempattu Thittam - special fund (Rs.154 crore for FY 2022-23 and Rs.1.25 crore FY 2023-24.

- **8.** After detailed deliberations, the Project Sanctioning and Monitoring Committee, in its third meeting held on 06.04.2023 has approved the following proposals of the Principal Secretary / Commissioner, Greater Chennai Corporations and Director of Municipal Administration, subject to the conditions specified in the appraisal report of respective projects.
- 1) Upgradation / improvement of roads in Greater Chennai Corporation at an appraised cost of Rs.66.22 crore (special fund for road development Rs.61.25 crore + Greater Chennai Corporation share Rs.4.97 crore) under Nagarpura Salai Mempattu Thittam for the financial year 2023-24 as given in the table 2.

- **9.** In the letter sixth read above, the Additional Chief Secretary/Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has requested the Government to issue necessary administrative orders for the project of Greater Chennai Corporation and Director of Municipal Administration under Nagarpura Salai Mempattu Thittam special fund for the financial year 2022-23 and 2023-24 as detailed in para 8 above.
- 10. The Government after careful examination of the proposal of the Additional Chief Secretary/Chairman and Managing Director Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited and approval of the State level Project Sanctioning and Monitoring Committee, have decided to accept the said proposal and accord administrative sanction for the following projects of Greater Chennai Corporation and Director of Municipal Administration under Nagarpura Salai Mempattu Thittam Special Fund for the financial year 2022-23 and 2023-24, subject to the conditions specified in the appraisal report of the respective projects:
- I. Greater Chennai Corporation Laying of 689 roads (black top, cement concrete roads) at a cost of Rs.66.22 crore (Nagarpura Salai Mempattu Thittam Special Fund share: Rs.61.25 crore Urban Local Body (ULB) share: Rs.4.97 crore)
