The Director of Municipal Administration has requested to release a sum of **Rs.2264.17 lakhs** being the Government of India share of Rs.1224.55 lakhs now released and GOTN share of Rs.1039.62 lakhs (Rs.1224.55 lakhs + Rs.1039.62 lakhs totally **Rs.2264.17 lakhs**) as Central and State share for the above 22 ULBs.

3. The Government after careful consideration, sanction the release of a sum of **Rs.2264.17 lakhs** (Government of India share of Rs.1224.55 lakhs and GOTN share of Rs.1039.62 lakhs (Rs.1224.55 lakhs + Rs.1039.62 lakhs totally **Rs.2264.17 lakhs**) for the above 22 Urban Local Bodies mentioned in para 1 above.

4. The Director of Municipal Administration is authorized to draw the above amount by means of cheque to be drawn in favour of DMA's BSUP account No.30120509278 so as to release the amount to the above-mentioned 22 ULB's. The above amount would be released from Basic Services to the Urban Poor accounts only after obtaining administrative sanction from the competent authority.
