ORDER:

In the letter 1<sup>st</sup> read above the Government of India has sanctioned and released a sum of Rs.272.72 lakhs for implementation of schemes under BSUP in the following four Urban Local Bodies.

The Government after careful consideration of the proposal of the Director of Municipal Administration sanction and release a sum of Rs. 521.21 lakhs (Rupees five hundred and twenty one lakhs and twenty one thousand only) being 1<sup>st</sup> installment of the Government of India and Government of Tamil Nadu share to the above 4 Urban Local Bodies for implementing the scheme of Basic Services to Urban Poor under JNNURM.
