#### ORDER:

In the G.O. first read above, the Government approved the Engineering Manual for Urban Local Bodies in Tamil Nadu for adoption.

2. In the G.O. second read above, an amendment was issued to para 2.7.3. of chapter II of the said Manual, inter-alia, constituting a committee as follows:-

1.	Commissioner of Municipal Administration.	-	Chairperson
2.	Superintending Engineer, Office of the Commissioner of Municipal Administration.	-	Member Secretary.
3.	Engineering Director, Chennai Metropolitan Water Supply and Sewerage Board./ Engineering Director, TWAD	-	Member for water supply and sewerage projects
4.	Chief Engineer, Highways Department.	-	Member (for roads and bridge projects).
5.	Chief Engineer, Public Works Department.	-	Member (for building / bus stand / commercial projects)
6.	An Officer Finance Department i/c. of the post of Financial Advisor & Chief Accounts Officer, in the Office of the Commissioner of Municipal Administration.	-	Member
7.	Municipal Commissioner & Municipal Engineer of concerned Urban Local Body.	-	Members

3. Now, the Director of Municipal Administration in his letter third read above has requested the Government to issue the following amendments;

(i) deletion of the word, " even after 3 calls" in para 2.7.2 so that the tenders can be disposed off by the appropriate committee early; and

(ii) As the post of Superintending Engineer in the Office of the Director of Municipal Administration has been upgraded to 'Chief Engineer', appropriate changes may be made to the G.O.(Ms)34, Municipal Administration and Water Supply Department, dated 22.3.2006 and Para No.2.7.2 of the Engineering Manual.

The Government after careful examination accept the proposal of the Director of Municipal Administration and issue the following amendments to the Engineering Manual for Urban Local Bodies in Tamil Nadu approved in G.O.(Ms) No.34, Municipal Administration and Water Supply Department, dated 22.3.2006.

### AMENDMENT

In Chapter-II, Para 2.7.2 of Engineering Manual Volume I, the words "even after 3 calls" shall be deleted and the expression, "Chief Engineer" shall be inserted after "Superintending Engineer".
