ORDER:

In the G.O. first read above, an amendment was issued to para 2.7.3. of chapter II of the Engineering Manual of ULBs in Tamil Nadu, inter-alia, constituting a committee for approval of the tenders exceeding 10% of the tender value.

2. In the letter second read above, the Director of Municipal Administration has suggested that an amendment may be issued to the said Manual by inserting a new para as follows:-

(i) " Before the bids are placed before the Tender Award Committee, the technical bids of the tender for works mentioned in the table, will be scrutinized by the technical members (for respective works) of the Tender Award Committee & recommend to open the price bids of the qualified bidders and to reject the nonqualified bidders as non-responsive.

(ii) " In as much as the post of Superintending Engineer in CMA has been upgraded as Chief Engineer, "the term Superintending Engineer, O/o. CMA wherever it come shall be read as CE, O/o.CMA.

3. The Government after careful examination direct that the following amendment be issued to chapter II of the Engineering Manual for Urban Local Bodies in Tamil Nadu:-

AMENDMENT

- (i) In Chapter-II of the Engineering Manual for Urban Local Bodies in Tamil Nadu, after para 2.7.2 the following shall be added as Para 2.7.3:

"Before the bids are placed before the Tender Award Committee, the technical bids of the tender for works mentioned in the table, will be scrutinized by the technical members (for respective works) of the Tender Award Committee & recommend to open the price bids of the qualified bidders and to reject the nonqualified bidders as non-responsive"

- (ii) In as much as the post of Superintending Engineer in Director of Municipal Administration has been upgraded as Chief Engineer wherever the expression "Superintending Engineer, O/o. Director of Municipal Administration" occurs it shall be read as "Chief Engineer, O/o. the Director of Municipal Administration"
