



## ABSTRACT

Tamil Nadu Government Servants Conduct Rules, 1973 – Amendment to fourth proviso to rule 24A – Issued.

### ORDER:

In the G.O first read above, orders were issued that the Government Servants proceeding on Hajj Pilgrimage to Saudi Arabia through Tamil Nadu Hajj Committee on "Pilgrim pass" are exempted from obtaining "No-objection Certificate".

2. In the G.O second read above, orders have been issued that the existing system of issuing "Pilgrim pass" has been dispensed with and the Government servants/ officials including employees of Public Sector Undertakings/ Corporations proceeding for Hajj pilgrimage to Saudi Arabia on "temporary Hajj passports" with a validity of eight months for Saudi Arabia only through Tamil Nadu State Hajj Committee are exempted from obtaining "No Objection Certificate" from the Heads of Department concerned.

3. Consequent on the above orders, the Government have decided to amend the fourth proviso to rule 24A of Tamil Nadu Government Servants' Conduct Rules, 1973.

4. The following Notification will be published in the Tamil Nadu Government Gazette:-

### NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Government Servants' Conduct Rules, 1973.

2. The amendment hereby made shall be deemed to have come into force on the 5<sup>th</sup> October, 2009.

**AMENDMENT.**

In the said Rules, in the fourth proviso to rule 24-A, for the expression "Pilgrim pass", the expression "Temporary Hajj passports with a validity of eight months for Saudi Arabia", shall be substituted.


