ORDER:

The Managing Director, Tamil Nadu Slum Clearance Board in his letters read above has stated that, the project for construction of 2232 tenements (G+5) at Ukkadam in Coimbatore District under Basic Services to the Urban Poor (a submission under Jawaharlal Nehru National Urban Renewal Mission) has been approved by State Level Coordination Committee and Central Sanctioning and Monitoring Committee with the following funding pattern:-

i) Approved Cost of Project	Rs.5535.54 lakhs
ii) Government of India Share	Rs.2069.00 lakhs
iii) Government of Tamil Nadu Share	Rs.1705.18 lakhs
iv) Implementing Agency Contribution	Rs.1397.54 lakhs
v) Beneficiary contribution	Rs. 363.82 lakhs

2. The Managing Director, Tamil Nadu Slum Clearance Board has also stated that, in view of the high value of the land for the proposed project, the board in its Resolution No.29/414, dated 23.1.08 has approved to adopt G+5 framed structure and also revised the project cost to Rs.5930.91 with reference to the Schedule of Rates for 2007-2008.

3. Subsequently in the Board's Resolution No.15/424 dated 12.11.2008, the Tamil Nadu Slum Clearance Board has approved the proposal for

construction of 2232 tenements at Ukkadam in Coimbatore District at the revised Project Cost of Rs.6749.95 lakhs, under Basic Services to the Urban Poor, adopting 2008-2009 schedule of rates with the following funding pattern:-

The Managing Director, Tamil Nadu Slum Clearance Board, has therefore, requested the Government, to accord administrative sanction for the construction of 2232 tenements at Ukkadam in Coimbatore District at the Project cost of Rs.6749.95 lakhs with the funding pattern mentioned in para 3 above, under Basic Services to the Urban Poor (BSUP).

5. The Government, after careful consideration, have decided to accept the proposal of the Managing Director, Tamil Nadu Slum Clearance Board and accord administrative sanction for construction of 2232 tenements with Infrastructure facilities at Ukkadam in Coimbatore District at a Project cost of Rs.6749.95 lakhs (Rupees Six Thousand Seven Hundred and Forty Nine lakhs and Ninety Five Thousand only) with the funding pattern mentioned in para 3 above, under Basic Services to the Urban Poor (BSUP) – a submission under Jawaharlal Nehru National Urban Renewal Mission.
