## ORDER:

The Managing Director, Tamil Nadu Slum Clearance Board in his letters read above has stated that the project for construction of 1608 tenements (G+3) at Ammankulam in Coimbatore District under Basic Service to the Urban Poor (a submission under Jawaharlal Nehru National Urban Renewal Mission) has been approved by State Level Coordination Committee and Central Sanctioning and Monitoring Committee with the following funding pattern:-

i) Approved Cost of Project Rs.4102.79 lakhs

ii) Government of India Share Rs.1555.63 lakhs

iii) Government of Tamil Nadu Share Rs. 1293.53 lakhs

iv) Implementing Agency Contribution Rs. 991.53 lakhs

v) Beneficiary contribution Rs. 262.10 lakhs

The Commissioner of Municipal Administration has been nominated as Nodal Agency for the above said Scheme.

 The Managing Director, Tamil Nadu Slum Clearance Board has also stated that adopting disaster resistant building guidelines the Tamil Nadu Slum Clearance Board has approved revised financial statement for the project cost of Rs.4459.10 lakhs based on schedule of rates for the year 2007-2008 vide Board's resolution No.18, Dated 12.03.08 and subsequent revision in schedule of rates the project cost was revised to Rs.4842.19 lakhs.

3. The Managing Director, Tamil Nadu Slum Clearance Board has added that, the people occupying the project site at Ammankulam expressed their inability to vacate their present houses and move out elsewhere outside the city in view of the present livelihood and their wards' education and hence, the Tamil Nadu Slum Clearance Board could commence with the works for 936 tenements only within the available land apart from encroached / occupied area. The Managing Director, Tamil Nadu Slum Clearance Board has further stated that, the Board has therefore decided to take up the balance 672 tenements as Phase II at Ukkadam scheme area wherein required land is available for construction in the Board's Resolution No.19/426 dated 12.1.2009, the Tamil Nadu Slum Clearance Board has approved the proposal for construction of 1608 tenements at Ammankulam in Coimbatore District at the revised Project Cost of Rs.4998.86 lakhs, under Basic Services to the Urban Poor (a submission under Jawaharlal Nehru National Urban Renewal Mission) with the following funding pattern:-

The Managing Director, Tamil Nadu Slum Clearance Board, has therefore, requested the Government, to accord administrative sanction for the construction of 1608 tenements at Ammankulam in Coimbatore District (Phase I & II) at a Project cost of Rs.4998.86 lakhs, with the funding pattern mentioned in para 3 above, under Basic Services to the Urban Poor a submission under Jawaharlal Nehru National Urban Renewal Mission Scheme.
- 5. The Government, after careful consideration have decided to accept the proposal of the Managing Director, Tamil Nadu Slum Clearance Board and accord administrative sanction, for construction of 1608 tenements with Infrastructure facilities at Ammankulam in Coimbatore District (Phase I & II) at a Project cost of Rs.4998.86 lakhs (Rupees Four Thousand Nine Hundred and Ninety Eight lakhs and Eighty Six Thousand only) with the funding pattern

mentioned in para 3 above, under Basic Services to the Urban Poor - a submission under Jawaharlal Nehru National Urban Renewal Mission Scheme.
