### **ORDER:-**

Due to acute summer Tiruvannamalai district is facing severe drinking water scarcity and requires immediate financial assistance to combat the problem. The Collector of Tiruvannamalai has sent comprehensive plan to combat drinking water scarcity in Rural and Urban areas. The Collector has stated that deficit rainfall has been recorded in the district. He has also stated that in order to tackle the impending water scarcity on a war footing financial assistance is required urgently.

2. The Principal Secretary/Commissioner of Revenue Administration has examined the above proposal and recommended that a total sum of Rs.200 lakhs may be sanctioned to Tiruvannamalai District which is facing severe water scarcity.

3. The Government accordingly accept the proposal of Principal Secretary/Commissioner of Revenue Administration and sanction a sum of Rs.200 lakhs (Rupees Two hundred lakhs only) from Calamity Relief Fund to combat acute water scarcity in Tiruvannamalai District, as detailed below:-

4. Necessary additional funds will be provided in RE/FMA 2010 - 2011. Pending provision of funds, the Principal Secretary/ Commissioner of Revenue Administration is authorized to draw and disburse the amount sanctioned in paragraph 3 above to the District Collector, Tiruvannamalai. This item of expenditure shall be brought to the notice of Legislature by specific inclusion in Supplementary Estimates for the year 2010 -2011. He is also requested to include this item of expenditure while sending the proposals for RE/FMA 2010-2011 and FSE 2010 - 2011 to the Government in Finance Department without fail.

5. The expenditure shall be restricted to the actual requirement and the balance amount if any should be surrendered. Funds shall not be diverted without prior orders of Government. Utilisation certificate in this regard shall be sent to the Government for the amount sanctioned above.

6. This order issues with the concurrence of Finance Department, vide its U.O. No. 76/DS(B)/2010-1, dated 15.04.2010 and ASL No. 27 (Twenty Seven).
