ORDER:

The Department of Information Technology, Ministry of Communications and Information Technology, Government of India have accorded administrative approval for implementation of the Project "Pilot e-District Project" for implementation in 5 Districts of Thiruvavur, Krishnagiri, Perambalur, Ariyalur and Coimbatore.

2. The Government of India have prescribed the following major core services:

- Issue of Certificate of Domicile, Nativity, Caste, Marriage, Income, Employment etc.,
- Social Welfare Pensions
- Revenue Court cases
- Government dues and recovery
- PDS, and
- RTI services

3. As per the guidelines of the Government of India, the State Project Committee has to be set up and the committee shall be duly empowered to take decision on the implementations strategy, process reengineering requirements and make all policy level decisions. The State Level Committee has to coordinate with functionaries of various concerned District Administration and Government Departments as well as District level officers for ensuring smooth implementation of the e-District Vision, Mission and Objectives. The State Implementation Committee has to be set up by the Government along with District Implementation Committee. The Committees have to meet regularly and review the progress of implementation.

4. The Chief Executive Officer, Tamil Nadu e-Governance Agency has therefore requested the Government to set up the State Project Committee and District Level Monitoring Committee for the successful implementation of the 'e-District' Project.
