#### **Order:**

The Director of Municipal administration in his letter read above has stated that the objective of the preparation of Human Development Report (HDR) for Urban Local Bodies is to generate a study report reflecting the status of human development, gender development, empowerment of women and children, poverty in the urban areas and highlight the interventions of the Government / Urban Local Bodies required correct the imbalances and to start with, the study will be undertaken for the five Municipal Corporations viz., Coimbatore, Madurai, Tiruchirapalli, Salem and Tirunelveli.

2) The estimated consultancy cost for the preparation of Human Development Report (HDR) for the above five Corporations will be Rs.25.00 lakhs (Rupees Twenty Five lakhs only). TOR for the Human Development Report (HDR) will be prepared in consultation with the State Planning Commission. The Director of Municipal Administration, has therefore, requested to allot a grant of Rs.25.00 lakhs( Rupees Twenty Five lakhs only) under the part –II Schemes for 2009-2010 for the preparation of Human Development Report (HDR) for the above five Corporations.

3) The Government, after careful examination, accept the proposal and sanction a sum of Rs.25.00 lakhs (Rupees Twenty Five lakhs only) for preparation of Human Development Report (HDR) for Urban Local Bodies for the five Municipal Corporations viz., Coimbatore, Madurai, Tiruchirapalli, Salem and Tirunelveli under Part II Scheme for the year 2009-2010.
