### **ORDER:**

The Managing Director, Chennai Metropolitan Water Supply & Sewerage Board in his letter first read above has stated that in order to remove silt from the manholes in the sewerage system, so as to minimize the sewer obstructions, additional jet rodding machines are required and there he has proposed to procure 10 numbers of jet rodding machines and one jetting cum suction machine at a cost of Rs.315.00 lakhs under Part-II Schemes for the year 2009-2010. The State Planning Commission and the Standing Finance Committee have approved the Scheme.

2. The Government after careful examination, accept the proposal of the Managing Director, Chennai Metropolitan Water Supply & Sewerage Board and sanction a sum of Rs.315.00 (Rupees Three hundred and fifteen lakhs only) as grant for Procurement of 10 numbers of jet rodding machines and 1 number of jetting cum suction machine under Part – II Schemes for the year 2009-10.

3. The amount sanctioned in para 2 above shall be debited to the following head of account:-

2215 – Water Supply and Sanitation – 01 – Water Supply – 101. Urban Water Supply Programmes – Schemes in the Eleventh Five Year Plan – II State Plan – KE Grants to CMWSSB for Procurement of jet rodding machines and jetting cum suction machine 09 – Grants in Aid – 01. Grants for Current Expenditure (DPC 2215 01 101 KE 0915)

(Rt) No.1251, Fin(W&M.II)Department, dated.30.12.2005.

5. The Commissioner of Treasuries and Accounts is authorized to draw and disburse the amount sanctioned in para 2 above to Chennai Metropolitan Water Supply and Sewerage Board, Chennai-2, as indicated in para 4 above.
